



IMPORTANT INFORMATION - ABSENTEE VOTING BY MAIL
PRESIDENTIAL PREFERENCE PRIMARY & SPECIAL ELECTION: MARCH 12, 2024
VOTER REGISTRATION DEADLINE: FEBRUARY 12, 2024

Voters are reminded that once you return your voted mail absentee ballot, it has been cast and your vote is final. We will not be able to cancel your voted mail ballot and allow you to vote in-person.

➤ ***Who may request a Mail Absentee Ballot?***

A family member may request an absentee ballot on behalf of a voter if they are residing temporarily out of the county or municipality, or if they have a physical disability. Only the following individuals may request an Absentee Ballot on behalf of a voter:

- ☑ The voter - him or herself;
- ☑ Voter's mother, father, grandparent, aunt, uncle, brother, sister, spouse, son, daughter, niece, nephew, grandchild, son-in-law, daughter-in-law, mother-in-law, father-in-law, brother-in-law, or sister-in-law;

The requestor must be the age of 18 or over. Relatives applying for absentee ballots for a voter must also sign an oath on the application.

➤ ***When will Mail Absentee Ballots be Mailed?***

FEBRUARY 12, 2024 THROUGH MARCH 1, 2024

➤ ***How & Where do I return my Mail Absentee Ballot?***

- USPS Mail or Express Delivery (Postage Needed)
- Personal Delivery to Office Drop Box or Office Counter (No Postage Needed)

➤ ***When may I return my Mail Absentee Ballot?***

No later than 7pm on Election Day (an exception for Military & Overseas Citizens). **IMPORTANT NOTE:** Each ballot must be returned in its own individual signed Envelope (included with the Ballot).

➤ ***Who may return a Mail Absentee Ballot? O.C.G.A. § 21-2-385(a)***

Only the following individuals may Mail or Deliver a Mail Absentee Ballot on behalf of a voter:

- ☑ The voter - him or herself;
- ☑ Voter's mother, father, grandparent, aunt, uncle, brother, sister, spouse, son, daughter, niece, nephew, grandchild, son-in-law, daughter-in-law, mother-in-law, father-in-law, brother-in-law, or sister-in-law;
- ☑ Individual residing in the same household as the voter;
- ☑ If Disabled, Caretaker of a voter with disabilities.
- ☑ If Jailed or other Detention Facility, Any Staff of such Jail or Facility.

NOTE: The Collection of and Returning of Ballots by others, organizations, or groups (Ballot Harvesting) is not permitted.
